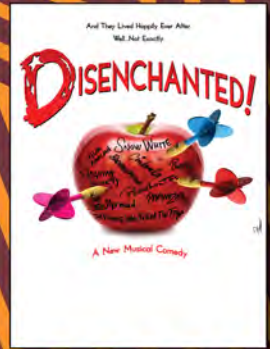

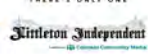

# What We Do

The mission of the Littleton Town Hall Arts Center is to enrich the cultural, social, and educational life of the community through professionally produced live theatre, concerts, other cultural events, and year-round educational programs for children and adults. 2018-19 marked our 37th anniversary.

Attendance for the first 4 shows this season totaled over 20,000 - 2,200 of whom attended a THAC event for the first time.

Unfortunately, COVID shut us down in March of 2020 with 5 performances left of *Barefoot in the Park*. We would not be able to perform for a live audience in our building for the remainder of 2020.

We were able to move *Almost Heaven* outside to Hudson Gardens in August of 2020 and performed for over 1,500 patrons in a safe, distanced, outdoor environment. The entire staff pulled together to make this show happen during the cancelled COVID season.

## Concerts, Covid, and Re-Invention

During the remainder of 2020, we continued to re-invent what we did as a theatre. Live productions with audiences were on hold. So we asked ourselves: "What can we do now?"

The entire THAC team switched gears to create streaming content to keep our patrons connected. We all learned new skills and continued to move forward.

The Town Hall Board provided endless support for our staff to continue to create alternative programming.

### Highlights

- We created an online learning platform for our kids program, that hosted over 80 students.
- We created a series of mini concerts called "Behind The Mask", with 8 different artists offering virtual performances.
- We filmed several full length concerts, including a Christmas special.
- We created streaming productions of "*Almost Maine*" and "*A Gentleman's Guide to Love and Murder*".
- We created 2 small in person kids musicals over the summer.





## Stanton Art Gallery

During the 2019-2020 season, four artists were featured in the Stanton Art Gallery. The first, Michael Dowling, has worked with and shown at the Museum of Contemporary Art Denver and Denver Art Museum, and has work in several private and public collections both nationally and throughout Europe.

Colorado native Jeff Velarde's work was featured during *Meet Me in St. Louis*. Velarde is a graduate of Denver West High School and an Alum at the Colorado Institute of Art. Velarde has worked as a commercial artist for over 35 years while pursuing a parallel career as a Fine Artist.

Then there was mixed media artist Tara Pappas, who strives to create visual stories, embodying the timelessness of the fantastic and its connection with the ordinary.

Artist Tim Brenner spent his career in the art world and is a signature member of the Colorado Watercolor Society. His traditional transparent watercolor styled work was featured during *Barefoot in the Park*.

## Town Hall Arts Center Education Programming

Town Hall's Educational Program was challenged over and over during 2020, but we adapted quickly, and brought arts education to the students.

We created a full online learning platform for kids in March/April/May and served over 80 students.

We then continued the virtual teaching over the entire year to make sure everyone had access to arts and education through Town Hall.

During the summer of 2020, we were able to have small in-person pods of 10 kids, so we created two full musical camps and those students were able to be onstage and once again build those connections with each other.

The fall classes found more in-person kids classes, but an additional shutdown had us pull back to virtual. Still we finished all their productions on line and were able to offer them to a wider at home audience. We even produced a virtual Christmas Carol that had a cast of a dozen kids and was watched by a live audience of close to 100 people.

We still managed to serve close to 3500 kids through live, filmed, and virtual outreach.

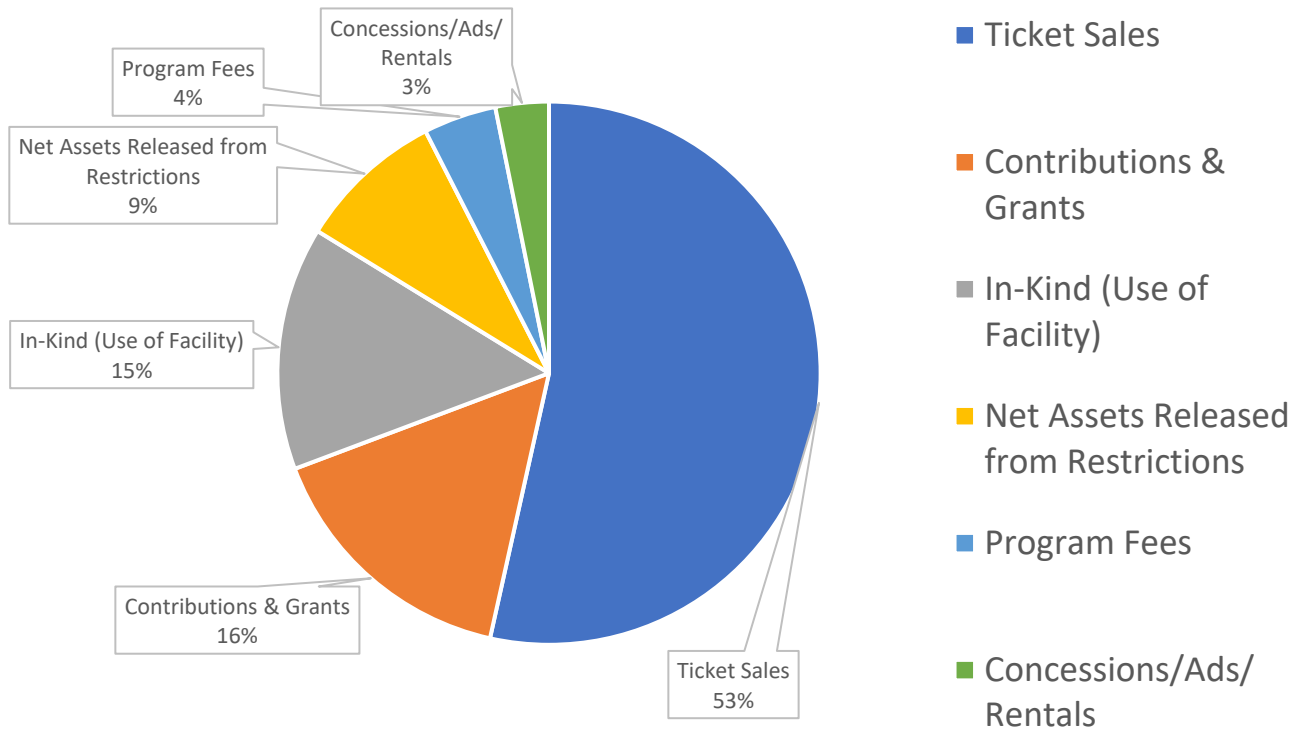

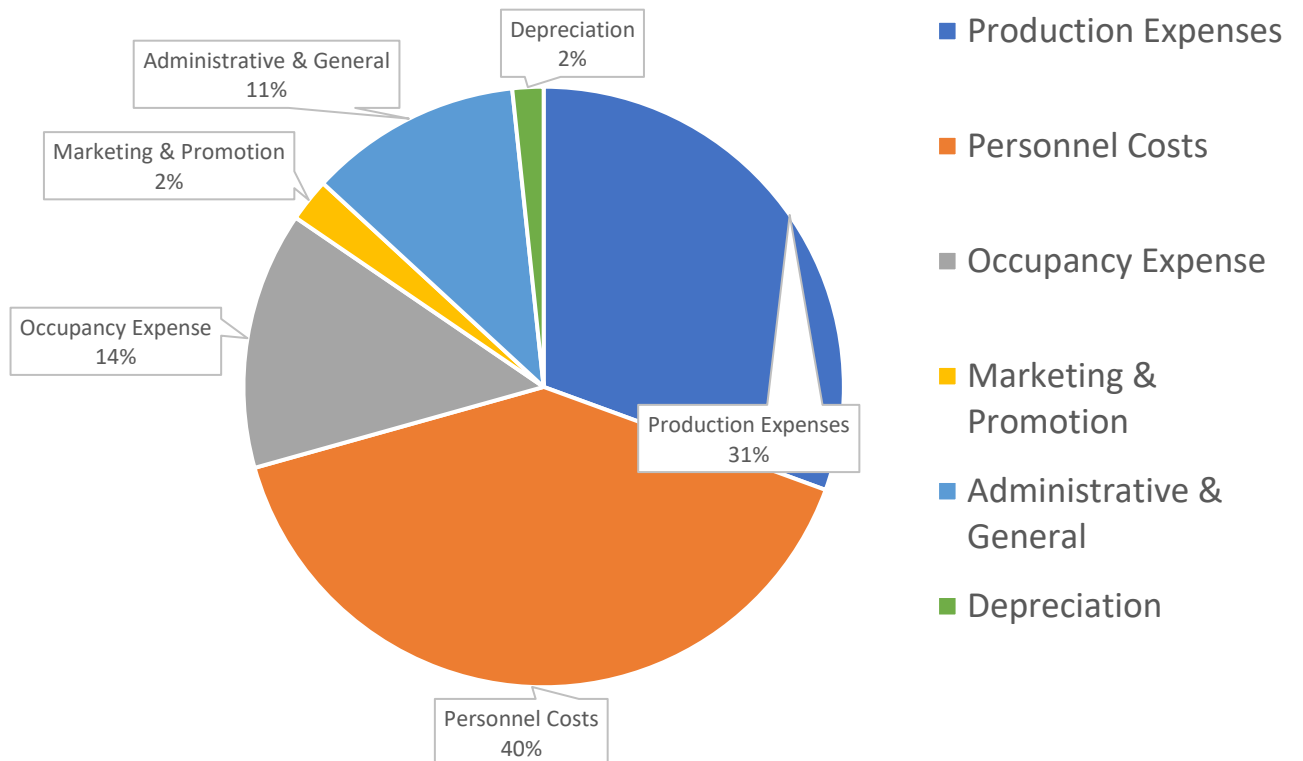
